## ANNEXURE - I

### **GENERAL TERMS AND CONDITIONS OF AUCTION SALE**

1. Bidders / Purchasers are advised to inspect the materials under auction sale along with the committee members on 09.03.2024 from 10.00 am to 12.00 noon, satisfy themselves regarding the nature, description, condition of the material before submitting their bids and attend in the auction sale meeting on the same day at 2.30 P.M. for submission of theirs bids.
2. Intending bidders / purchasers shall have to deposit Rs. 200/- (Two hundred) only towards EMD cost (Which will be refunded to the unsuccessful bidders) before offering their bid.
3. **Submission of Bid Forms:**
  - (a) Bids in the prescribed format (Annexure-1) shall be submitted before the committee. Bids submitted otherwise shall not be eligible for consideration and shall be rejected. No complaint on time-factor or paucity of time for bidding will be entertained.
  - (b) Bids form shall be duly filled in with all the relevant details and signed at each page by the bidder.
  - (d) Incomplete/unsigned bids without EMD will be summarily rejected.
  - (e) Copy of AADHAR Card / Photo Identity Card issued by Govt. and PSU will be accepted as the identity
  - (f) Original Identity Document copy of which is submitted along with the bid form must be produced on demand.
4. The successful bidder will be declared on 09.03.2024 at 4.00 P.M. after completion of the bidding process and a confirmation letter will be issued to the successful bidder to collect the material under bid.
5. The bidding agencies would be required to lift the entire item under bid in one go. No pick and choose method of collection will be allowed.
6. After collection of the materials, those will be assembled in one place for weighing / counting and assessment of the purchase price by the auction sale committee.
7. The bidder shall have to deposit the entire purchase price calculated on the same day in the college cash counter deducting the EMD Money deposited.
8. On payment of the entire purchase price, Sale Certificate will be issued by the Principal in the name of the successful bidder.
9. **Delivery of possession and Lifting Period:**
  - (a) All expenses and incidental charges thereto shall be borne by the auction purchaser. The purchaser is obliged to lift all items engaging own labour.
  - (b) Entire quantity has to be lifted within a period of 3 days from the date of issue of Sale Certificate. Any delay in lifting material shall attract a penalty of Rs.100/- for each day of delay.
10. The Committee will be at liberty to amend/ modify/ delete any of the conditions as may be deemed necessary in the light of facts and circumstances.
11. The Committee reserves the right to accept or reject all or any bid or bids without assigning any reason and to postpone or cancel the sale without assigning any reason.
